 5 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the
 6 names of each applicant upon the membership roll of the Tohono O'odham Nation in
 7 accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH. Day
 9 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;
 10 -0- NOT VOTING; and [01]ABSENT, pursuant to the powers vested in the Council by Section 1 of
 11 Article II and Section of 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation,
 12 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
 13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
 14 of June 18, 1934 (48 Stat. 984).
