

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Certification of the Tohono O'odham Eligible Adult Members
Listing for Third Per Capita 32nd Approved Listing Payout Distribution)

RESOLUTION NO. 09-232

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per**
10 **Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Third Per Capita**
12 **Revenue Allocation Plan on July 28, 2006; and**

13 **WHEREAS, the Enrollment Program submits to the Tohono O'odham Legislative Council the**
14 **Certification Listing for eligible adult members for review and approval for the third**
15 **per capita distribution; and**

16 **WHEREAS, the total verified adult members for the third per capita 32nd payout distribution is**
17 **06; and**

18 **WHEREAS, pursuant to Resolution No. 06-624 the Legislative Council approved the Master Listing**
19 **for Eligible Adult members; and**

20 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**
21 **verification of a member's eligibility and further certification by the Tohono O'odham**
22 **Legislative Council.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 24 **1. Accepts and approves the Certification Listing for 06 eligible adult members for**
25 **the Third Per Capita 32nd approved listing payout distribution.**
- 26 **2. Authorizes (a) the transfer of \$12,000.00 from the Third Per Capita Money Market**
27 **Account to the Third Per Capita Checking Account established at Bank of America;**
28 **and (b) upon the authorized signature of the Nation, issuance of a check on the**

1 **Third Per Capita Checking Account in the amount of (i) \$2,000.00 to each Eligible**
2 **Member residing in the United States and listed in the Certification Listing of**
3 **Eligible Members and (ii) \$1,400.00 to each Eligible Member residing outside the**
4 **United States and listed in the Certification Listing of Eligible Members, with the**
5 **Balance of \$600.00 withheld and remitted to the Internal Revenue Service**
6 **pursuant to the requirements of federal law.**


7 **3. Designates Sells as the distribution site for the disbursement of the 32nd and**
8 **subsequent payouts of the third per capita checks to members of the Nation.**

9 **4. Authorizes the Chairman of the Nation to execute such other documents as may be**
10 **necessary to implement this Resolution.**

11 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of**
12 **funds to each additional eligible adult Tohono O'odham member is contingent upon**
13 **verification of a member by the Enrollment Program and further certification of**
14 **additional eligible members by the Tohono O'odham Legislative Council.**


15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 4TH Day**
16 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
17 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
18 **and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**
