

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 09-173 - Approving the Certification of the Tohono O'odham
Eligible Adult Members Listing for Third Per Capita 31st Approved Listing
Payout Distribution)

RESOLUTION NO. 09-234

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per**
6 **Legislative Council Resolution No. 06-307; and**

7 **WHEREAS, the Enrollment Program discovered due to human error one name was duplicated on**
8 **the third per capita thirty-first payout distribution list; and**

9 **WHEREAS, the Enrollment Program request to amend Resolution No. 09-173 to delete the**
10 **duplicated entry of one name: Rita A. Contreras and to change the listing count from**
11 **6 to 5 for the third per capita thirty-first payout distribution list; and**

12 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**
13 **verification of a member's eligibility and further certification by the Tohono O'odham**
14 **Legislative Council; and**

15 **WHEREAS, the dollar amount will change to \$10,000.00 to reflect the 5 adult members eligible for**
16 **the Third Per Capita thirty-first payout distribution.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

18 **1. Approves and Authorize to amend Resolution No. 09-173 to delete the duplication**
19 **of one name: Rita A. Contreras and to change the Certification Listing count from**
20 **6 to 5 eligible adult members for the Third Per Capita thirty-first payout**
21 **distribution.**

22 **2. That the transfer of funds sum \$10,000.00 will reflect the 5 eligible adult members**
23 **certified by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH. Day**
25 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
27 **and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
