

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2009 638 Corrections Program Carry over Savings in the  
amount of \$890,304.00)**

RESOLUTION NO. 09-238

1 WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and  
2 Corrections Programs under the 638 BIA Master Contract; and

3 WHEREAS, the Tohono O'odham Nation Police Department (TONPD) Corrections Program has  
4 received a carry over savings amount of \$890,304.00; and

5 WHEREAS, with this increase a budget amendment was created to increase line items and create  
6 new line items; and

7 WHEREAS, the newly created line item are 720 Supplies - office, 710 - Utilities, 812 Public  
8 Relations, 867 Awards.


9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
10 approves the carryover amount in Budget Amendment No. 2 for the 638 Corrections  
11 program in the amount of \$890,304.00 with the Indirect Cost amount is \$53,174.57 for  
12 a total of \$943,478.57 and where the current FY 2009 budget is \$4,862,409.66.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council hereby approves the newly  
14 created line items are 720 Supplies - Office, 710 - Utilities, 812 - Public Relations, 867  
15 Awards.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the  
17 Chairman and any designated official to expend and administer the budget as  
18 attached, provided that any amendments affecting the funds or funding level shall be  
19 submitted for further prior approval by the Tohono O'odham Legislative Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>. Day  
21 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
22 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article IV,  
23 Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
26 Stat. 984).
