

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Extension of the U.S. Department of Homeland Security, Federal Emergency Management Agency 2006 Assistance to Firefighters Grant No. EMW-2006-FG-18408)

RESOLUTION NO. 09-239

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to local fire**
2 **departments through the Federal Emergency Management Agency's Assistance (FEMA)**
3 **to Firefighters Grant Program to assist in providing public safety services within their**
4 **respective jurisdictions; and**

5 **WHEREAS, the Tohono O'odham Nation has been awarded a grant to purchase dispatch software**
6 **and communication equipment on a reimbursed match basis of ninety-five percent**
7 **from Federal funds (no more than \$89,775.00) and five percent from the recipient**
8 **(Tohono O'odham Nation); and**

9 **WHEREAS, the Tohono O'odham Nation Fire Department has allocated the five percent share of**
10 **\$4,725.00 within the Department's Fiscal Year 2009 Budget; and**

11 **WHEREAS, the Tohono O'odham Legislative Council approved acceptance of this grant under**
12 **Resolution No. 08-533; and**

13 **WHEREAS, account number 11-1089 was assigned to this grant and posted by the budget office in**
14 **FY 08; and**

15 **WHEREAS, the performance period for the grant ended on September 20, 2008; and**

16 **WHEREAS, FEMA has approved an extension of the program performance period to June 25, 2009;**
17 **and**

18 **WHEREAS, the extension request as been reviewed and approved by the Office of Grants and**
19 **Contracts, Executive Office, Domestic Affairs Committee, Budget & Finance**
20 **Committee, and the aforementioned offices and committees recommend approval by**
21 **the Legislative Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **extension of Assistance to Firefighters Grant No. EMW-2006-FG-18408 by way of**
24 **reimbursement of funds for the Tohono O'odham Nation for the purchase of**
25 **equipment under the United States Department of Homeland Security, Federal**
26 **Emergency Management Agency 2006 Assistance to Firefighters Grant Program**
27 **through June 25, 2009.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the carry over**
29 **of account 11-1089 into FY 09 in the amount of \$89,775.**

30 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Fire Department is authorized to**
31 **expend grant funds from September 2008 through June 25, 2009, provided however,**
32 **that any amendment affecting the funding or funding levels be submitted for further**
33 **prior approval to the Tohono O'odham Legislative Council.**
