add new line items for Construction and Professional Services)

RESOLUTION NO. 09-240

- 1 **WHEREAS, the Tohono O'odham Nation Facility Management Department submits for review and**
2 **approval the attached FY 2009 Budget Amendment Number 2; and**
- 3 **WHEREAS, the budget is amended to decrease line item 01-1050-750 (Major Capital) in the amount**
4 **of \$30,222.19 and line item 01-1050-772 (RM Building) in the amount of \$20,000.00, for**
5 **a total amount of \$50,222.19; and**
- 6 **WHEREAS, the budget amended is to add new line item 01-1050-779 (Construction) in the amount**
7 **of \$50,222.19 for purpose of completion for the Administration Building North**
8 **Walkway Upgrade; and**
- 9 **WHEREAS, the budget is amended to decrease line item 01-1050-750 (RM Building) in the amount**
10 **of \$ 33,000.00; and**
- 11 **WHEREAS, the budget is amended to add new line item 01-1050-810 (Professional Services) in the**
12 **amount of \$33,000.00 to provide services from the Interim Pesticide Program for all**
13 **the Tohono O'odham Nation buildings; and**
- 14 **WHEREAS, the Fiscal Year 2009 Budget Amendment Number 2 for the Tohono O'odham Nation's**
15 **Facility Management Department has been reviewed by the Tohono O'odham**
16 **Legislative Council Budget & Finance Committee and approves to add new line items**
17 **for construction and professional services.**
- 18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **the Tohono O'odham Nation's Facility Management Department Fiscal Year 2009**
20 **Budget Amendment Number 2 which adds new line items 01-1050-779 (Construction)**
21 **in the amount of \$50,222.19 and 01-1050-810 (Professional Services) in the amount of**
22 **\$33,000.00 for the construction of the Administration Building North Walkway**
23 **Upgrade per attached budget.**
- 24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
26 **authorized to administer the Fiscal Year 2009 Facility Management Budget**
27 **Amendment Number Two.**
- 28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH. Day**
29 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article IV,**
31 **Section 1 (d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
