

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the FY 2009 State IV-B Contract Budget Amendment with Resolution
#08-276 for Division of Child Welfare Services)**

RESOLUTION NO. 09-242

1 **WHEREAS, the Tohono O'odham Nation, through the Division of Child Welfare Services, has**
2 **historically operated a Family Preservation Program to promote safe and stable**
3 **families; and**

4 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY2009 State**
5 **IV-B Contract Budget in the amount of \$72,710.30, effective October 1, 2008 through**
6 **September 30, 2009 with Resolution #08-276, State IV-B Contract Budget; and**

7 **WHEREAS, the actual award letter for FY2009 is for the amount of \$65,745.00. A budget**
8 **amendment is needed to decrease the budget amount from \$72,710.30 to \$65,745.00.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **amend and authorize the Budget Amendment to reflect the decrease by \$6,965.30 and**
11 **authorize the Executive Branch to expend funds for the FY2009 State IV-B Contract**
12 **Budget Amendment attached, effective October 1, 2008 through September 30, 2009,**
13 **in the amount of \$65,745.00.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**
15 **Chairman and any designated official are hereby authorized to negotiate, execute and**
16 **expend the grant.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day**
18 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
