

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving New FY 2009 Department of Health and Human Services Title IV-B, Subparts
1 & 2 Carryover Budgets for Division of Child Welfare Services)

RESOLUTION NO. 09-243

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**
5 **safe and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**
7 **through the P.L. 93-638 master contract, specifically the BIA Social Services budget for**
8 **child welfare services and the BIA ICWA budget for Family Preservation Program, as**
9 **authorized by both P.L. 93-638 and the Department of Health and Human Services; and**

10 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two-year expenditure**
11 **period, beginning October 1, 2007 and ending September 30, 2009, funding only the**
12 **two fiscal years of FY 2008 and FY 2009; and**

13 **WHEREAS, the Department of Health and Human Services has provided attached 269 financial**
14 **status reports for carryover allocation amounts for these budgets as:**

15 **1. \$14,286.51 for Title IV-B, Subpart 1 Budget, Acct. 11-1337.**

16 **2. \$19,083.78 for Title IV-B, Subpart 2 Budget, Acct. 11-1338; and**

17 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**
18 **attached and incorporated by this reference, to be effective October 1, 2007 through**
19 **September 30, 2009 and request authorization to expend carryover funds in the fiscal**
20 **year of FY 2009.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approves new FY 2009 Department of Health and Human Services Title IV-B, Subparts**
23 **1 & 2 Carryover Budgets and authorizes the Executive Branch to expend carryover**
24 **funds for the budgets attached, effective October 1, 2008 through September 30, 2009,**
25 **inclusive of budget modifications throughout this period, in the following amounts:**

26 **1. FY09 Title IV-B, Subpart 1 Budget = \$14,286.51.**

27 **2. FY09 Title IV-B, Subpart 2 Budget = \$19,083.78.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**
29 **Chairman and any designated official are hereby authorized to negotiate, execute and**
30 **expend the grant.**
