

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 92-456, "Adopting the Rules Committee Plan of Operation")**

RESOLUTION NO. 09-247

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Legislative Council,**
3 **standing committees, boards, and special committees pursuant to the Constitution**
4 **of the Tohono O'odham Nation, Article VI, Section 1(a) and (b); and**

5 **WHEREAS, in 1992 the Legislative Council adopted a Plan of Operation for the Rules Committee**
6 **pursuant to Resolution No. 92-456, "Adopting the Rules Committee Plan of Operation";**
7 **and**


8 **WHEREAS, the Rules Committee has recently developed an updated Plan of Operation to reflect**
9 **its current powers, oversight authority, membership, meetings, and other matters;**
10 **and**

11 **WHEREAS, because the Rules Committee's updated Plan of Operation will replace the plan**
12 **adopted pursuant to Resolution No. 92-456, it is necessary to rescind Resolution No.**
13 **92-456.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
15 **hereby rescinds Resolution No. 92-456, "Adopting the Rules Committee Plan of**
16 **Operation."**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
18 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a)&**
20 **(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
