


**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Plan of Operation for the Rules Committee)**

LEGISLATIVE ORDER NO. 09-248

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Legislative Council,**  
3 **standing committees, boards and special committees pursuant to the Constitution of**  
4 **the Tohono O'odham Nation, Article VI, Section 1(a) and (b); and**  
5 **WHEREAS, the Tohono O'odham Legislative Council is empowered to prescribe the duties and**  
6 **powers of all Legislative Council committees; and**  
7 **WHEREAS, the Rules Committee has updated the purposes, powers, and duties appearing in its**  
8 **Plan of Operation and recommends the Plan's adoption by the Legislative Council.**  
9 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
10 **adopts the attached Plan of Operation for the Rules Committee as dated for reference**  
11 **May 2009.**

12 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>. Day of**  
13 **MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR;-0- AGAINST; -0-**  
14 **NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) & (b)**  
15 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
16 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
17 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
