

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY09 CCDF Discretionary Funds, Budget Amendment #1, Account 11-1291)**

RESOLUTION NO. 09-250

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**
2 **successfully providing services and assistance to eligible Tohono O'odham children**
3 **and families; and**

4 **WHEREAS, the FY09 CCDF Discretionary Funds, Budget Amendment #1, Account 11-1291 has been**
5 **reviewed and approved by the Human Resources Development Committee and Budget**
6 **and Finance Committee; and**

7 **WHEREAS, The original FY09 Discretionary Funds Budget was based on the FY08 allocation, and**
8 **this Amendment #1 reflects an increase in the amount of \$63,825.00, as reflected in the**
9 **FY09 Grant Award Notice for Discretionary Funds in the amount of \$393,890.00; and**

10 **WHEREAS, this Amendment #1 reflects the addition of line item 812 Public Relations, and line**
11 **item 816 Certificates.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Child Care & Development Fund FY09 Discretionary Funds, Budget**
14 **Amendment #1 Account 11-1291 by increasing the budget from \$330,065.00 to**
15 **\$393,890.00 an increase of \$63,825.00.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the addition**
17 **of line item 812 Public Relations, and line item 816 Certificates.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's Officials, to wit; the Chairperson and any designated official are authorized**
20 **to negotiate and expend the budget, provided however, that any amendments**
21 **affecting the funds or funding levels of the budget shall be submitted for further prior**
22 **approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
24 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Article VI,**
26 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
