

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY09 CCDF Mandatory Funds, Budget Amendment #1, Account 11-1219)

RESOLUTION NO. 09-251

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**
2 **successfully providing services and assistance to eligible Tohono O'odham children**
3 **and families; and**

4 **WHEREAS, the FY09 CCDF Mandatory Funds, Budget Amendment #1, Account 11-1219 has been**
5 **reviewed and approved by the Human Resources Development Committee and Budget**
6 **and Finance Committee; and**

7 **WHEREAS, The original FY09 Mandatory Funds Budget was based on the FY08 allocation, and this**
8 **Amendment #1 reflects an increase in the amount of \$98,890.00, as reflected in the**
9 **FY09 Grant Award Notice for Mandatory Funds in the amount of \$672,584.00.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the Child Care & Development Fund FY09 Mandatory Funds, Budget**
12 **Amendment #1 Account 11-1219 by increasing the budget from \$573,694.00 to**
13 **\$672,584.00 an increase of \$98,890.00.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials, to wit; the Chairperson and any designated official are authorized**
16 **to negotiate and expend the budget, provided however, that any amendments**
17 **affecting the funds or funding levels of the budget shall be submitted for further prior**
18 **approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
20 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
