RESOLUTION NO. 09-257

1 **WHEREAS, the United States Department of Homeland Security has distributed grants within the**
2 **program period that was introduced on 11/01/06 to individual states, to fund**
3 **equipment purchases, training and other programs by departments that provide**
4 **public safety services within their respective jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state for**
6 **the purpose of obligating and distributing funds from the U.S. Department of**
7 **Homeland Security, Office of Grants and Training, Homeland Security Grant Program**
8 **on a reimbursement basis for notification and equipment for vehicle purchase in FY**
9 **2008 and other needs for homeland security; and**

10 **WHEREAS, on 01/16/07, the Tohono O'odham Nation was awarded a grant from the State of**
11 **Arizona, Department of Homeland Security in the amount of \$45,000.00 as part of the**
12 **2007 State Homeland Security Program Grant No. 2007-GE-T7-0006 for the purchase**
13 **of notification and equipment for prime vehicle purchase in FY 2008 and other needs**
14 **for homeland security; and**

15 **WHEREAS, the 2007 State Homeland Security Program Grant No. 2007-GE-T7-0006 approval the**
16 **use of carry forward of unexpended funds of \$5,159.25 has been reviewed by the Grants**
17 **& Contracts Department, Executive Office, Domestic Affairs Committee and Budget &**
18 **Finance Committee, of which all recommend acceptance of the grant award by the**
19 **Legislative Council; and**

20 **WHEREAS, the original line number 750 Major Capital will be changed to 771 Operational–Repair**
21 **& Maintenance of Vehicles for installation and maintenance of emergency notification**
22 **and lighting equipment for the vehicle purchase in FY 2008 and other required**
23 **equipment under the Homeland Security Grant.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **use of carry forward of unexpended funds for Grant No. 2007-GE-T7-0006 in the**
26 **amount of \$5,159.25 on a reimbursement basis from the Tohono O'odham Nation**
27 **General Fund and further waives any additional indirect cost to administer this grant.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Office of Emergency Management is**
29 **authorized to expend funds from this grant in accordance with the terms of the 2007**
30 **State Homeland Security Program Grant No. 2007-GE-T7-0006 award period of**
31 **11/01/06 to 07/31/09, with any extensions of time reasonably necessary which are**

3 **BE IT FURTHER RESOLVED** that the original line number 750 Major Capital will be removed and
4 adding line number 771 Operational -Repair & Maintenance of vehicles.

5 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes the Office of
6 the Chairman or designee to enter into any necessary agreements therefore accepting
7 the above mentioned U.S. Department of Homeland Security, State Homeland Security
8 grants.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
10 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;
11 -0- NOT VOTING; and [06]ABSENT, pursuant to the powers vested in the Council by Article IV,
12 Section 1 (d)(2) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
13 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
14 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
15 Stat. 984).


