

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Intergovernmental Agreement with the Arizona Department of Economic Security for the One Stop Division of the Education Department)

RESOLUTION NO. 09-260

1 WHEREAS, the Tohono O'odham Nation (the "Nation") has negotiated an Intergovernmental
2 Agreement ("IGA") with the Arizona Department of Economic Security for the One Stop
3 Division of the Education Department; and

4 WHEREAS, the Nation will provide Employment Services utilizing Workforce Investment Act (WIA)
5 Title V money to eligible Youth, Adults, and Dislocated Workers throughout the
6 reservation effective July 01, 2008 through June 30, 2009; and

7 WHEREAS, the Tohono O'odham Legislative Council Resolution 09-087 approved the One Stop
8 Division Budget in the amount of \$22,215.00 but excluded a negotiated and authorized
9 IGA.

10 WHEREAS, the Intergovernmental Agreement was reviewed by the Human Resources
11 Development Committee, the Budget & Finance Committee, and the Office of Attorney
12 General.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14 Intergovernmental Agreement (IGA) between the Tohono O'odham Nation and Arizona
15 Department of Economic Security for a term effective July 1, 2008 through June 30,
16 2009.

17 BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman or Vice-Chairman is hereby
18 authorized to execute the IGA and any subsequent amendments to extend the term of
19 the IGA provided that any amendment affecting the funding or funding levels of the
20 budget shall be submitted for approval by the Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
22 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;
23 -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI
24 Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
25 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
