

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 08-259 "Approving FY 2009 Projected Revenues to the Nation in the Amount of \$74,902,000" to Decrease Projected Revenues to the Nation)**

**RESOLUTION NO. 09-264**

1 **WHEREAS, the Legislative Council is vested with the power "to manage any funds within the**  
2 **exclusive control of the Tohono O'odham Nation" (Constitution of the Tohono**  
3 **O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Legislative Council previously adopted FY 2009 projected revenues to the Nation**  
5 **in the amount of \$74,902,000 (Resolution No. 08-259); and**

6 **WHEREAS, the Budget and Finance Committee and Commerce Committee have reviewed more**  
7 **recent FY 2009 revenue projections and recommends that the FY 2009 projected**  
8 **revenues to the Nation adopted by Resolution No. 08-259 be amended and decreased**  
9 **by \$5,591,476.07 thereby decreasing the total FY 2009 projected revenues to the Nation**  
10 **from \$74,902,000 to \$69,310,523.93.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**  
12 **Resolution No. 08-259 to decrease FY 2009 projected revenues to the Nation by**  
13 **\$5,591,476.07 thereby decreasing the total FY 2009 projected revenues to the Nation**  
14 **from \$74,902,000 to \$69,310,523.93.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>. Day**  
16 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; 444.7 AGAINST;**  
17 **-0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Article VI**  
18 **Section 1 (d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
