

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2010 Projected Revenues to the Nation in the Amount of \$68,879,156)

RESOLUTION NO. 09-266

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any
2 funds within the exclusive control of the Tohono O'odham Nation" (Constitution of the
3 Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

4 WHEREAS, the Legislative Budget and Finance Committee, Commerce Committee, and the
5 Executive Office reviewed the revenue projections and available revenue for FY 2010;
6 and

7 WHEREAS, the Legislative Budget and Finance Committee and the Executive Office recommend
8 the adoption of the FY 2010 revenue projections in the amount of \$68,879,156 to fund
9 the Nation's tribal budgets for FY 2010.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
11 approves FY 2010 projected revenues in the amount of \$68,879,156, including
12 \$5,680,138 from the FY 2010 general fund surplus, for the purpose of funding the FY
13 2010 tribal budgets of the Tohono O'odham Nation.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day
15 of MAY, 2009 at a meeting at which a quorum was present with a vote of 1,881.9 FOR; 498.0 AGAINST;
16 -0- NOT VOTING; and 154.6[05] ABSENT, pursuant to the powers vested in the Council by Article VI
17 Section 1 (d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
18 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
