

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting and Approving the Executive Branch Fiscal Year 2010 Tribal Budget and  
Appropriating Funds in the Amount of \$59,769,844.57)**

RESOLUTION NO. 09-268

1 WHEREAS, the Executive Branch has prepared and presented its fiscal year 2010 tribal budgets  
2 to the Tohono O'odham Legislative Council; and

3 WHEREAS, the Executive Branch Fiscal Year 2010 Budget for the period beginning October 01,  
4 2009 ending September 30, 2010 has been presented to the Legislative Council both  
5 in summary as Schedule 1 as well as in detailed budgets (collectively, "Executive  
6 Branch FY 2010 Budget") that by this reference are all incorporated into this  
7 Resolution.

8 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve and  
9 appropriates \$59,769,844.57 from general fund revenues to fund the Executive Branch  
10 Fiscal Year 2010 Budget.

11 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes  
12 the expenditure of funds appropriated to and in accordance with the Executive Branch  
13 FY 2010 Budget for the period beginning October 01, 2009 ending September 30, 2010.

14 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
15 Chairman, Vice-Chairman and any designated official are authorized to administer  
16 the Executive Branch FY 2010 Budget, provided however that any amendments  
17 affecting the aggregate total of the funds originally budgeted for the purposes for  
18 which the funds were budgeted shall be submitted for prior approval by the Tohono  
19 O'odham Legislative Council.


20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day  
21 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
22 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI  
23 Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
26 Stat. 984).
