

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2010 Legislative Branch Budget)**

RESOLUTION NO. 09-269

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority "to manage any funds within the exclusive control of the Tohono O'odham**
3 **Nation . . . and to appropriate these funds for the benefit of the Nation and its**
4 **members" provided that "[a]ll expenditures of these funds shall be pursuant to**
5 **appropriations or budgets" authorized by resolution or ordinance (Constitution,**
6 **Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY 2010**
8 **Legislative Branch Budget, which is incorporated by this reference; and**

9 **WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY**
10 **2010 Legislative Branch Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
12 **and authorizes expenditure of the FY 2010 Legislative Branch Budget in the amount**
13 **of \$3,289,869.84, as per the attached budget, beginning October 1, 2009 and ending**
14 **September 30, 2010.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
16 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; 444.7 AGAINST;**
17 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI**
18 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**
