RESOLUTION NO. 09-273

1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative**  
 2 **cost of implementing the provisions of the Initiative; and**  
 3 **WHEREAS, the Initiative Administrative Cost Fund was established to fund the necessary initiative**  
 4 **administrative requirements; and**  
 5 **WHEREAS, the Executive Branch has prepared an FY 2010 budget to continue its Initiative**  
 6 **administration; and**  
 7 **WHEREAS, the total FY 2010 Initiative Administrative Budget in the amount of \$ 1,587,624.98 and**  
 8 **projected FY2009 unexpended balance are as follows:**

 23 **from the Nation’s gaming revenues held in the Nation’s Desert Diamond Savings**  
 24 **Account to fully fund the proposed FY 2010 Initiative Administrative Budgets; and**  
 25 **WHEREAS, the FY 2010 Initiative Administrative budgets have been presented to the respective**  
 26 **Legislative Council oversight committees for review.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**

21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and [05]ABSENT, pursuant to the powers vested in the Council by Article VI**  
25 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
