

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family
Assistance – FY2010 Food Distribution Program Nutrition Education Funding
Budget Account No. 11-1316)

RESOLUTION NO. 09-278

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2009 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**
5 **(commodity foods) and nutrition education to eligible households through tailgate**
6 **runs throughout the Nation and nearby towns;**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation**
8 **for FY2010 through the USDA in the amount of \$1,800.00; and**

9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
10 **Division, Food Distribution Program has submitted the FY2010 Nutrition Education**
11 **funding budget in the amount of \$1,800.00 for review and approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
13 **authorizes the expenditure of the FY2010 Food Distribution Nutrition Education**
14 **budget in the amount of \$1,800.00, in accordance with the attached budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Chairperson and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level shall be**
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day**
20 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [06]ABSENT, pursuant to the powers vested in the Council by Article VI**
22 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


