- 1 **WHEREAS, prevention of injuries is a priority for the Tohono O'odham Nation; and**
- 2 **WHEREAS, domestic violence is a source of injuries from the individuals and family members;**
- 3 **and**
- 4 **WHEREAS, the Domestic Violence Program of the Health and Human Services-Community Health**
- 5 **Division and the Domestic Violence Coalition is working to raise awareness of**
- 6 **domestic violence and continue the development of services for domestic violence**
- 7 **victims and their families; and**
- 8 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services received a**
- 9 **Family Violence Prevention and Services grants in FY 2009 for a total of \$133,198.00;**
- 10 **and**
- 11 **WHEREAS, the grant has expenditure period effective, May 10, 2008 and ending September 30,**
- 12 **2010; and**
- 13 **WHEREAS, the Administration from Children and Families requests authorization to expend**
- 14 **funds from October 1, 2009 through September 30, 2010 in the amount of \$133,198.00.**
- 15 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council hereby:**
- 16 **1. Accepts and approves the grant award DHHS/ACF Violence Prevention and Services**
- 17 **Budget effective May 10, 2008 and ending September 30, 2010 and authorizes the**
- 18 **expenditure of funds in the amount of \$ 133,198.00.**
- 19 **2. Approves the Family Violence Prevention and Services budget and authorizes the**
- 20 **Department of Health and Human Services Community Health Division to expend**
- 21 **such funds retro active to October 1, 2008 through September 30, 2010 in the**
- 22 **amount of \$133,198.00.**
- 23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
- 24 **Nation's official, to wit: the Chairman and Vice Chairman and any designated official**
- 25 **are authorized to administer and expend these funds, provided however, that any**
- 26 **amendment affecting the funds or funding levels of the contract shall be submitted**
- 27 **for further prior approval by the Tohono O'odham Legislative Council.**






