

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Tohono O'odham Department of Health and Human Services Youth**  
**Suicide Prevention Grant FY 2010)**

RESOLUTION NO. 09-282

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**  
2 **substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application to the U.S. Department of**  
4 **Health and Human Services/Center for Mental Health Services for a Youth Suicide**  
5 **Prevention Program grant to provide programs to reduce youth suicides and increase**  
6 **wellness, on May 6, 2006; and**

7 **WHEREAS, the Notice of Award was received for Fiscal Year 2007 on October 1, 2006 in the amount**  
8 **of \$400,000 for the first year of a three-year grant; and**

9 **WHEREAS, the Notice of Award was received for Fiscal Year 2008 on June 20, 2007 in the amount**  
10 **of \$400,000 for the second year of the grant and approximately on July 1, 2008 for Year**  
11 **Three for FY 2009; and**

12 **WHEREAS, a request for carryover funding and for a one-year no-cost extension are being**  
13 **submitted for FY 2010; and**

14 **WHEREAS, of the total grant amount of \$400,000 the budget for FY 2010 reflects the current**  
15 **indirect costs of 19.35%; and**

16 **WHEREAS, the Youth Suicide Prevention grant for \$400,000 for a no-cost extension for Year Four**  
17 **of the grant is hereby submitted for review and approval by the Tohono O'odham**  
18 **Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
20 **approves and authorizes expenditures in accordance with the FY 2010 proposed**  
21 **budget for a Youth Suicide Prevention grant, and attached budget in the amount of**  
22 **\$400,000 for a one year extension of a three year grant.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairman, and any designated official to expend and administer the budget, as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>. Day**  
28 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI**  
30 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**
