1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial in**  
2 **providing financial assistance to eligible low-income households in meeting utility**  
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2010 through the State of Arizona,**  
5 **Department of Economic Security, Community Services Administration is \$38,390.00;**  
6 **and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the budget for FY2010 funding**  
8 **through the State of Arizona, Department of Economic Security, Community Services**  
9 **Administration in the amount of \$38,390.00 for contract period July 01, 2009 through**  
10 **June 30, 2010; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
12 **Division, Low Income Home Energy Assistance Program has submitted the FY2010 Low**  
13 **Income Home Energy Assistance budget in the amount of \$38,390.00 for review and**  
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
16 **authorizes the expenditure of the FY2010 Low Income Home Energy Assistance**  
17 **Program (LIHEAP) budget in the amount of \$38,390.00 in accordance with the attached**  
18 **budget.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level shall be**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>. Day**  
24 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI**  
26 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**
