

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Child
Welfare Services, FY 2010 Child Welfare Division Revenue Budget)

RESOLUTION NO. 09-288

1 **WHEREAS, the Tohono O'odham Nation (Nation) has conducted the Nation's Division of Child**
2 **Welfare Services and related events, such as the annual Children's Homes' Christmas**
3 **Party, under the supervision of the Nation's Department of Health and Human**
4 **Services, with funds authorized and appropriated by the Nation; and**

5 **WHEREAS, funding appropriated by the Nation provides a base, for which the Division of Child**
6 **Welfare Services operates its programs and related events; and**

7 **WHEREAS, the Division of Child Welfare Services has solicited donations and other fundraising**
8 **in order to supplement funds budgeted for the Division of Child Welfare Services and**
9 **related events; and**

10 **WHEREAS, by Resolution No. 06-771, the Tohono O'odham Legislative Council authorized the**
11 **creation of an account for the Nation's Department of Health and Human Services,**
12 **Division of Child Welfare Services to use, receive and expend any and all funds from**
13 **sponsors, donors, sales and fundraising, to supplement funds allocated by the Nation;**
14 **and**

15 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY2010 Child**
16 **Welfare Division Revenue Budget attached and incorporated by this reference, to be**
17 **effective October 1, 2009 through September 30, 2010 and requests authorization to**
18 **expend funds in the amount of \$8,150.00 with no Indirect Costs, based upon historical**
19 **donations and fundraising.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve and authorize the Executive Branch to expend funds for the FY2010 Child**
22 **Welfare Division Revenue Budget attached, effective October 1, 2009 through**
23 **September 30, 2010 in the amount of \$8,150.00 with no Indirect Costs, funded by**
24 **donations and fundraising.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
26 **Chairman and any designated official to expend and administer the budget as**
27 **attached, provided that any budget amendments affecting the funds or funding levels**
28 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
29 **Council.**


