 2 **2010 Budget was developed and funded from the Department of Economic Security –**
 3 **State of Arizona Workforce Investment Act (WIA) Title 1-B through projected allocation**
 4 **effective July 01, 2009, and ending June 30, 2011 in the amount of \$225,520.00; and**
 5 **WHEREAS, the PY 08 / FY 09 Education Department – One Stop Division Budget was approved**
 6 **through Tohono O'odham Legislative Council Resolution No. 08-615; and**
 7 **WHEREAS, the Department of Economic Security – State of Arizona has projected release of funds**
 8 **in the amount of \$225,520.00 for PY 09/ FY 2010 program year to be delivered to the**
 9 **Nation through the IGA; and**
 10 **WHEREAS, the Education Department – One Stop Division has five (5) program budgets and**
 11 **request to expend these budgets per attached budgets; and these budgets as identified**

5 approval by this Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day
7 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;
8 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI
9 Section 1 (d)(2)&1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
10 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
11 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
12 Stat. 984).


