

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2010 Department of Health and Human Services Child Care and**  
**Development Fund Budgets)**

**RESOLUTION NO. 09-295**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child Care**  
4 **Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
6 **Budgets as attached and incorporated by this reference, to be effective October 1, 2009**  
7 **through September 30, 2010 and requests authorization to expend funds for the FY**  
8 **2010 Child Care and Development Fund (CCDF) in the amount of \$903,759.00 in the**  
9 **following budgets:**

- 10 1. **FY 2010 CCDF Mandatory Funds - \$502,309.49 + \$71,384.51 (IDC) = \$573,694.00.**
- 11 2. **FY 2010 CCDF Discretionary Funds - \$276,552.16 + \$53,512.84 (IDC) = \$330,065.00.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **approves the above listed CCDF Mandatory Funds Budget, and CCDF Discretionary**  
14 **Funds Budget for period October 1, 2009 through September 30, 2010.**

15 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**  
16 **program listed herein above and as attached in the amounts indicated, effective**  
17 **October 1, 2009 through September 30, 2010 for the FY 2010 Child Care and**  
18 **Development Fund Budgets:**

- 19 1. **FY 2010 CCDF Mandatory Funds - \$502,309.49 + \$71,384.51 (IDC) = \$573,694.00.**
- 20 2. **FY 2010 CCDF Discretionary Funds - \$276,552.16 + \$53,512.84 (IDC) = \$330,065.00.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Official, to wit: the Chairman and any designated official are authorized to**  
23 **negotiate and expend the budget, provided however, that any amendments affecting**  
24 **the funds or funding levels of the budget shall be submitted for further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day**  
26 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI**  
28 **Section 1(d)(2), (d)(3) and 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
