

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepts and Authorizes to Expend \$478,501.79 from Indian Health Service (I.H.S.)**  
**Memorandum of Agreement for the Solid Waste Management Program**  
**FY2010 I.H.S. Budget 10-1097)**

RESOLUTION NO. 09-296

1 WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement  
2 between the Solid Waste Management Program and the Indian Health Service and  
3 budget 10-1097 through Resolution 97-041; and

4 WHEREAS, the Solid Waste Management Program will submit a FY 2010 I.H.S. budget for dump  
5 closures in the amount of \$478,501.79; and

6 WHEREAS, the Solid Waste Management Program budget FY2010 I.H.S. budget 10-1097 has been  
7 reviewed by the Legislative Natural Resources Committee and the Legislative Budget  
8 and Finance Committee.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the  
10 acceptance and expenditure of \$478,501.79, from the I.H.S. Memorandum of  
11 Agreement, for the Solid Waste Management Program FY2010 I.H.S. budget 10-1097,  
12 in accordance with the budget attached hereto.

13 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the  
14 Tohono O'odham Nation's Officials, to wit: the Chairperson and any designated  
15 official are authorized to negotiate and execute the agreement, provided however,  
16 that any amendments affecting the funds or funding levels of the agreement shall be  
17 submitted for further approval.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day  
19 of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
20 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI  
21 Section 1(d)(2), (d)(3) and 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the  
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).






