

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(To Authorize the Acceptance and Expenditure of an Environmental Protection Agency Clean Water Act Grant for the Water Resources Department FY2010 Environmental Protection Agency Budget 11-5017, in the Amount of \$155,000.00 and an In-kind Services Match of \$8,158.00 from the Water Resources Department FY2010 SAWRSA Budget 21-1525)**

**RESOLUTION NO. 09-299**

1 **WHEREAS, the Water Resources Department was awarded an Environmental Protection Agency**  
2 **Clean Water grant for identifying and investigating groundwater contamination in the**  
3 **amount of \$155,000.00; and**

4 **WHEREAS, this grant requires an in-kind services match of \$8,158.00 from the Water Resources**  
5 **Department FY2010 SAWRSA Budget 21-1525; and**

6 **WHEREAS, the Water Resources Department FY2010 Environmental Protection Agency budget 11-**  
7 **5017 has been reviewed by the Tohono O'odham Legislative Water Resources**  
8 **Committee and Budget and Finance Committee.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **authorizes:**

11 **1. The acceptance and expenditure of the Environmental Protection Agency Clean**  
12 **Water Act Section 106 grant, in the amount of \$155,000.00, for the Water Resources**  
13 **Department FY2010 Environmental Protection Agency budget 11-5017, in**  
14 **accordance with the budget attached hereto.**

15 **2. An in-kind services match of \$8,158.00 from the Water Resources Department FY**  
16 **2010 SAWRSA budget 21-1525.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairman and any designated official to expend and administer the budget, as**  
19 **attached, provided that any amendments affecting the funds or funding levels of the**  
20 **budget shall be submitted for further prior approval by the Tohono O'odham**  
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day**  
23 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI and**  
25 **XVII Section 1(d)(2) & (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
