

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval and Acceptance of the Application of the FY2010 Grant Award USEPA General Assistance Program (GAP))

RESOLUTION NO. 09-300

1 **WHEREAS, Tohono O'odham Legislative Council accepted \$271,428.01 in new funding for the**
2 **continuation of the General Assistance Program (GAP) on May 28, 2008 by Resolution**
3 **No. 08-308; and**

4 **WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that extends from**
5 **August 1, 2006 through September 30, 2009 which requires annual applications for**
6 **new funding; and**

7 **WHEREAS, the Tohono O'odham Nation submitted a proposal to the USEPA Region 9 in the**
8 **amount of \$271,428.01 for the General Assistance Program for FY2010 which will be**
9 **awarded in Assistance Agreement; and**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
11 **the FY2010 proposed award amount of \$271,428.01 of new funding for the continuation**
12 **of the GAP Grant.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairperson and any designated official to expend and administer the budget as**
15 **attached, provided that any amendments affecting the funds or funding level shall be**
16 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
18 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI**
20 **Section 1 (g) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


