

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Clean Air Act Grant and approval of the FY2010 Budget)**

RESOLUTION NO. 09-302

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**
2 **safe guarding the health and well being of the Nation's members; and**

3 **WHEREAS, in the past and present, air quality issues have threatened the environment, health**
4 **and well-being, and the sovereignty of the Nation; and**

5 **WHEREAS, the United States Environmental Protection Agency (USEPA) has reserved \$60,000 of**
6 **Clean Air Act grant funding to support air quality activities; and**

7 **WHEREAS, the Clean Air Act grant would allow the Nation to conduct a Point Source Emissions**
8 **Inventory, a Needs Assessment, a Monitoring Plan and the ability to participate in**
9 **Regional Initiatives.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
11 **the FY2010 proposed award amount of \$60,000 of new funding for the continuation of**
12 **the CAA Grant.**

13 **BE IT FURTHER RESOLVED that the Council approves the attached budget and authorizes the**
14 **expenditure of funds according to this budget, which shall be in effect from October**
15 **1, 2009 to September 30, 2010.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval to the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day**
21 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [05]ABSENT, pursuant to the powers vested in the Council by Article VI**
23 **Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
