

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing the FY 2010 Hia-Ced O'odham Planning and Development
Budget in the Amount of \$27,795.05 to be funded from the Hia-Ced O'odham Planning &
Development Investment Account)**

RESOLUTION NO. 09-309

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 03-218 approving the**
2 **land acquisition of the Robert's Property by the Tohono O'odham Nation for the Hia-**
3 **Ced, as a land base and authorized the utilization of Gaming Savings funds in the**
4 **Amount of \$1.8 million dollars to purchase the land; and**

5 **WHEREAS, the Robert's Property land acquisition was finalized on October 2, 2003 in the amount**
6 **of \$1.5 million dollars; and**

7 **WHEREAS, pursuant to Resolution 03-218, "that any funds remaining be held in an investment**
8 **savings account to fund any unforeseen expenses for the Robert's Property, and that**
9 **the funding be obligated for the sole purpose"; and**

10 **WHEREAS, the Hia-Ced O'odham Program, in collaboration with the Hia-Ced O'odham Advisory**
11 **Committee is requesting an appropriation in the amount of \$27,795.05 to continue in**
12 **the development of the Hia-Ced O'odham land base.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **carryover amount of \$27,795.05 as the Hia-Ced O'odham Planning and Development**
15 **FY 2010 budget to be funded from the Hia-Ced O'odham Planning and Development**
16 **Investment Account.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Chairman**
18 **and any designated official to expend and administer the budget as attached, provided**
19 **that any amendments affecting the funds or funding level shall be submitted for**
20 **further approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
22 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI**
24 **Section 1(d)(2) & (3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**


