

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approves Head Start Program FY 2009 Budget Amendment/Modification #1**  
**Account #01-1211)**

**RESOLUTION NO. 09-315**

1 **WHEREAS, the Tohono O'odham Nation through the Head Start Program has been successfully**  
2 **providing services and assistance to eligible Tohono O'odham children and families;**  
3 **and**

4 **WHEREAS, the Head Start program was allocated a tribal match budget of \$427,100.47 from the**  
5 **Nation's general fund; and**

6 **WHEREAS, the Head Start Program amendment/modification #1 reflects a decrease in line item**  
7 **750 Major Capitol in the amount of \$7,701.33; and**

8 **WHEREAS, the Head Start Program amendment/modification #1 adds a new line item 650 tuition**  
9 **registration and includes the amount of \$7,701.33 to the line item; and**


10 **WHEREAS, the Budget and Finance and the Human Resources Development Committees have**  
11 **both reviewed and passed the 01-1211 budget amendment/modification #1.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **the amendment/modification #1, adding line item 650 tuition and registration to the**  
14 **01-1211 budget and adds \$7,701.33 into the line item 650.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman or Vice Chairman are hereby**  
16 **authorized to negotiate and expend the budget provided that any amendment**  
17 **affecting the funding or funding levels of the budget shall be submitted for approval**  
18 **by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. Day**  
20 **of MAY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI**  
22 **Section 1(d)(3)&(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
