

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Issuing Certificates of Election from the May 23, 2009 General Election for the Offices of  
Representatives and Alternates to the Tohono O'odham Legislative Council and Seating  
Such Elected Officials)**

**LEGISLATIVE ORDER NO. 09-320**

1 **WHEREAS, on Saturday, May 23, 2009 the Tohono O'odham Election Board conducted a general**  
2 **election for the offices of representatives and alternates to the Tohono O'odham**  
3 **Legislative Council and district councils; and**

4 **WHEREAS, the Election Board issued and posted its Certificate of Election Results dated May 23,**  
5 **2009, which is incorporated by this reference, in accordance with Section 6.K. of Article**  
6 **VII of the Uniform Election Ordinance, Ordinance No. 03-86; and**

7 **WHEREAS, Section 6.N. of Article VII of the Uniform Election Ordinance requires that the**  
8 **Legislative Council issue Certificates of Election to the candidate who receives the**  
9 **highest number of votes for each Legislative Council seat within 20 days after the**  
10 **Election Board has posted its Certificates of Election Results; provided, however, that**  
11 **(1) no election contest statement has been filed within the time allowed, (2) such a**  
12 **candidate holds no other elective public office of the Nation, and (3) that the**  
13 **chairperson-elect and vice-chairperson-elect resign any employment before being**  
14 **seated; and**

15 **WHEREAS, the period for contesting the 2009 general election has expired and no such contest**  
16 **has been filed in accordance with the requirements of Article VIII of the Uniform**  
17 **Election Ordinance.**

18 **NOW, THEREFORE, BE IT ORDERED that the Chairperson and Secretary of the Tohono O'odham**  
19 **Legislative Council are hereby authorized and directed on behalf of the Council to**  
20 **execute and deliver a Certificate of Election seating the following persons elected from**  
21 **their respective districts as representatives and alternates to the Tohono O'odham**  
22 **Legislative Council; provided that all such persons shall hold offices in accordance**  
23 **with the Uniform Election Ordinance for a term of four years or until their successors**  
24 **have been elected, certified and seated, namely:**
