

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Selecting Evonne Wilson as Legislative Council Secretary)**

LEGISLATIVE ORDER NO. 09-323

1 **WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to**
2 **“select from outside of its own membership a secretary” to “serve until replaced by the**
3 **council” (Constitution, Article V, Section 5); and**


4 **WHEREAS, Evonne Wilson was previously selected and currently serves and the Legislative Council**
5 **Secretary pursuant to Legislative Order No. 09-121; and**

6 **WHEREAS, if she is again selected, Evonne Wilson will serve as the Legislative Council Secretary**
7 **until replaced by the Legislative Council in accordance with the Nation's Constitution.**

8 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it selects**
9 **Evonne Wilson as the Legislative Council Secretary; provided that she shall serve until**
10 **replaced by the Legislative Council.**

11 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08TH Day of**
12 **JUNE, 2009 at a meeting at which a quorum was present with a vote of 1,983.9 FOR; 162.0 AGAINST;**
13 **449.6 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 5 of**
14 **Article V of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
