15 Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted
16 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).


