

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting 2009-2011 Legislative Council Committee Meeting Schedule)**

LEGISLATIVE ORDER NO. 09-341

1 **WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to**
2 **“establish rules and procedures to regulate all meetings of the . . . standing**
3 **committees,” (Constitution, Article VI, Section 1(a)); and**

4 **WHEREAS, “the legislative committees of the Legislative Council are the standing committees of**
5 **the Legislative Branch performing continuing functions for an indefinite time, whose**
6 **membership shall consist of representatives to the Legislative Council.” (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article XI, Section 1 (A)(1)); and**

8 **WHEREAS, on June 8, 2009, following the election of Chairperson, Vice-Chairperson, and selection**
9 **of Secretary, the Tohono O'odham Legislative Council elected committee members**
10 **and officers to the Council's 13 standing committees; and**

11 **WHEREAS, on June 9, 2009, the Rules Committee drafted a committee meeting schedule listing**
12 **regular committee meetings for 2009-2011.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
14 **approves the “2009-2011 Legislative Council Committee Meeting Schedule,” which is**
15 **dated for reference June 10, 2009 and which shall remain in effect until committee**
16 **memberships are elected following the Nation's 2011 general election.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 10TH Day of**
18 **JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR;-0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
