

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 Arizona Reimbursable Budget: Child and Adult Care Food Program)**

RESOLUTION NO. 09-343

1 WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2 State of Arizona; and

3 WHEREAS, the Arizona Department of Education through the Child and Adult Care Food Program
4 Service Agreement provides reimbursement of funds for food costs incurred based on
5 the guidelines identified in the agreements; and


6 WHEREAS, the Executive Branch developed and obtained committee approval of the following
7 budget as attached and incorporated by this reference, to be effective March 1, 2009
8 through September 30, 2009 and request authorization to expend funds.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 the Child and Adult Care Food Program and is authorized to expend funds in the
11 amount of \$107,397.36 effective March 1, 2009 through September 30, 2009.


12 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
13 Nation's Officials, to wit: the Chairman, Vice Chairman, and any designated official are
14 authorized to negotiate and execute the grant, provided however, that any
15 amendments affecting the funds or funding levels of the grant shall be submitted for
16 further prior approval.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day
18 of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
19 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI
20 Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).
