1 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Department**
2 **FY09 budget 10-5015 through Resolution No. 08-270, in the amount of \$133,806.87; and**

3 **WHEREAS, the Nation's Grants and Contracts Office has identified \$42,363.96 in FY08 carry-**
4 **forward funds; and**

5 **WHEREAS, the Water Resources Department is requesting that the FY08 carry-forward, in the**
6 **amount of \$42,363.96, be added the Water Resources Department FY09 budget 10-**
7 **5015, for a total budget of \$176,170.83; and**

8 **WHEREAS, the Water Resources Department is requesting that the line item 750 MAJOR CAPITAL**
9 **be added to the Water Resources Department FY09 budget 10-5015; and**

10 **WHEREAS, amendment 1 to the Water Resources Department FY09 budget 10-5015 has been**
11 **reviewed by the Legislative Water Resources Committee and the Budget and Finance**
12 **Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the:**

- 15 1. **Addition of FY08 BIA 638 carry-forward funds, in the amount of \$42,363.96 to the**
16 **Water Resources Department FY09 budget 10-5015, for a total of \$176,170.83.**
- 17 2. **The addition of line item 750 MAJOR CAPITAL to the Water Resources Department**
18 **FY09 budget 10-5015, in accordance with the budget attached hereto.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget, as**
21 **attached, provided that any amendments affecting the funds or funding levels of the**
22 **budget shall be submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH, Day**
25 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI**
27 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
