

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2009 Budget Amendment #1 for the Tohono O'odham Nation**  
**Vocational Rehabilitation Program, Grant Award H250D080009)**

**RESOLUTION NO. 09-352**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted vocational rehabilitation**  
2 **services from the US Department of Education Rehabilitation Services Administration**  
3 **(Section 121 Vocational Rehabilitation Services Projects for American Indians with**  
4 **Disabilities); and**

5 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**  
6 **be provided to eligible enrolled members of the Tohono O'odham Nation living on or**  
7 **near the Nation and other federally recognized Native Americans living on the Nation**  
8 **with disabilities; and**

9 **WHEREAS, an amendment to the FY 2009 budget is necessary in order to continue vocational**  
10 **rehabilitation services, and \$15,788.41 from Salaries and Fringe Benefits from the VR**  
11 **Technician position, \$425.00 from Tuition and Registration, \$594.00 from Travel**  
12 **Expense, \$500.00 from RM Building, \$10.00 from Computer Maintenance, \$500.00**  
13 **from Professional Services, \$1,000.00 from Public Relations, and \$100.00 from Awards**  
14 **will be placed in the Client Support and Special Activities line items; and**

15 **WHEREAS, the Budget Amendment has been reviewed by the Human Resources Development**  
16 **Committee and the Budget and Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
18 **approves the Vocational Rehabilitation Program's FY 2009 Budget Amendment #1 with**  
19 **the Indirect Cost charges decrease of \$3,080.02 and is now \$51,423.88; and the grand**  
20 **total remains at \$411,200.00.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairman and any designated official to expend and administer the budget as**  
23 **attached, provided that any amendments affecting the funds or funding level shall be**  
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day**  
26 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI**  
28 **Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
