1 **WHEREAS, Sells District–Big Field Community Resolution No. BF-31-08; Sells District Council**
2 **Resolution No. SD-90-08; Legislative Council Resolution No. 08-572 approved the Sells**
3 **District-Big Field Community Fiscal Year 2009 Budget and its justification; and**

4 **WHEREAS, the Ge Oidag Community has prepared and acquired approvals of the attached budget**
5 **Modification/Amendment and its justification with Ge Oidag Community Resolution**
6 **No. GO-29-09; Sells District Council Resolution No. SD-46-09; for adjustments to**
7 **address the needs of the people; and**

8 **WHEREAS, this Modification/Amendment will increase the amount of the line items for 612-**
9 **Occasional Appointments by \$6,400.00; 901-Firewood by \$100.00; and 902-**
10 **Miscellaneous Assistance \$300.00; and**

11 **WHEREAS, the increases will reduce the budgeted amounts for Line Items 720-Office Supplies by**
12 **\$300.00; 721-Other Supplies by \$400.00; 727-Materials \$3,000.00; 759-Equipment Other**
13 **\$2,000.00; 860-Special Activities \$1,000.00; and 710-Utilities \$100.00.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **Sells District-Ge Oidag Community Fiscal Year 2009 Budget Modification/Amendment**
16 **No. 1 of Gaming Revenues for the Ge Oidag Community Budget.**

17 **BE IT FURTHER RESOLVED that this Modification/Amendment will increase the amount of the line**
18 **items for 612-Occasional Appointments by \$6,400.00; 901-Firewood by \$100.00; and**
19 **902-Miscellaneous Assistance \$300.00, which will reduce the budgeted amounts for**
20 **Line Items 720-Office Supplies by \$300.00; 721-Other Supplies by \$400.00; 727-**
21 **Materials \$3,000.00; 759-Equipment Other \$2,000.00; 860-Special Activities \$1,000.00;**
22 **and 710-Utilities \$100.00.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
24 **District Chairperson and any designated District Official to expend and administer the**
25 **budget, as attached, provided that any modifications/amendments affecting the funds**
26 **or funding levels of the budget shall be submitted for further prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day**
29 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI**
31 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
