

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District - Ge Oidag Community FY09 Mining Royalties Budget
Modification/Amendment No. 1)**

RESOLUTION NO. 09-354

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 07-752 approved the equal**
2 **distribution of \$2,932,566.45 of Mining Royalties to the eleven districts of the Tohono**
3 **O'odham Nation; and**

4 **WHEREAS, Ge Oidag Community Resolution No. GO-46-08; Sells District Resolution No. SD-22-09;**
5 **and Tohono O'odham Legislative Council Resolution No. 09-140 approved the Sells**
6 **District's portion of this allocation in the amount of \$266,596.95 which was distributed**
7 **to each of the four communities in the amount of \$66,649.23 for Cowlic Community**
8 **and \$66,649.24 for each of the Ge Oidag Community, North Communities, and the Sells**
9 **Community; and**

10 **WHEREAS, the Ge Oidag Community has evaluated their needs and has recommended a**
11 **modification/amendment to the current Mining Royalties budget; and**

12 **WHEREAS, the modification/amendment would decrease Line Item #727 Building Materials by**
13 **\$20,000.00 and will increase Line Item #612 Occasional Appointments by \$20,000.00;**
14 **and**

15 **WHEREAS, the attached budget modification/amendment and its justification was reviewed and**
16 **approved with Ge Oidag Community Resolution No. GO-30-09; and Sells District**
17 **Resolution No. SD-47-09.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **Sells District - Ge Oidag Community Fiscal Year 2009 Mining Royalties Budget**
20 **Modification/Amendment No. 1 which will increase Line Item #612 Occasional**
21 **Appointments by \$20,000.00 and decrease Line Item #727 Building Materials by**
22 **\$20,000.00 as submitted.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
24 **District Chairperson and any designated District official to expend and administer the**
25 **budget according to its justification as attached, provided that any**
26 **modifications/amendments affecting the funds or funding levels of the budget shall**
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day**
29 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI**
31 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
