

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District FY 2009 Budget Amendments/Modifications for
Sikol Himatk Community)

RESOLUTION NO. 09-355

1 WHEREAS, the Tohono O'odham Legislative Council did convene on June 11, 2009 to address
2 issues pertaining to the Nation; and

3 WHEREAS, on May 30, 2009 at a regularly scheduled meeting, the Gu Achi District Council did
4 approved a budget modification for Sikol Himatk Community (Mod. #3, Resolution
5 #0509-394); and

6 WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review
7 the communities' budget modifications submitted by the Gu Achi District and
8 recommend for approval.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
10 approve the Gu Achi District FY 2009 budget amendments/modifications for Sikol
11 Himatk Community.

12 BE IT FINALLY RESOLVED that the amendment/modification does not affect the overall portion
13 of the Gaming Distribution of \$1,707,656.42 to the Gu Achi District.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
15 of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
16 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI
17 Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).


