

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Pia-Oik Community Amendment No. 1 Fiscal Year 2009)**

RESOLUTION NO. 09-356

1 **WHEREAS, the Gu-Vo District did bring forth the Pia-Oik Community's Amendment No. 1 for the**  
2 **Fiscal Year 2009 Budget; and**

3 **WHEREAS, the Pia-Oik Community is requesting adjustment to the justification in their FY' 2009**  
4 **Budget to assist the Community Members; and**

5 **WHEREAS, the proposed amendment from the Pia-Oik Community has gone through proper**  
6 **reviews from the Gu-Vo District and the Tohono O'odham Legislative Budget and**  
7 **Finance Committee; and**

8 **WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Amendment**  
9 **#1 for Pia-Oik Community amending justification.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the Budget Amendment #1 for Pia-Oik Community amending the justification of line**  
12 **item 852 Donation/Contribution- the original justification states**

13 ***"To provide donation to each head of household members for Thanksgiving and***  
14 ***Christmas Holiday Dinner. Budgeted @ \$200.00 per Holiday x 20 household = \$800.00***  
15 ***(First Come First Serve). To provide purchase of appliance/furniture to each head of***  
16 ***household. Budgeted @ \$800.00 per household x 20 households=\$16,000.00 (First***  
17 ***Come First Serve). To purchase exercise machines for community youth/members to***  
18 ***utilize. Budgeted @ \$1,000.00. To purchase mailboxes for community members.***  
19 ***Budgeted @ \$2,000.00."***

20 **And the amended justification addition is as follows;**

21 ***"To purchase evaporative coolers and water coolers for the community members***  
22 ***living in the community".***

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairman and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day**  
28 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,396.8 FOR; 198.7**  
29 **AGAINST; -0- NOT VOTING; and [03]ABSENT, pursuant to the powers vested in the Council by Article**  
30 **VI Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
