

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the FY 2009 Department of Health and Human Services, Family Assistance Division – Budget Amendment #2 – Account No. 01-1300)

RESOLUTION NO. 09-365

1 **WHEREAS, by Resolution Number 08-265, all tribal budgets were approved by the Tohono**
2 **O'odham Legislative Council which included the FY09 Department of Health and**
3 **Human Services, Family Assistance tribal budget Account No. 01-1300; and**

4 **WHEREAS, by Resolution Number 08-651, the Tohono O'odham Legislative Council approved**
5 **budget amendment #1 for the Family Assistance Division Tribal budget in the amount**
6 **of \$100,000.00 to provide burial assistance services to eligible members; and**

7 **WHEREAS, the Department of Health and Human Services has recognized the increased need in**
8 **the costs of burial assistance, general assistance and child assistance services and the**
9 **number of individuals and families requiring these services; and**

10 **WHEREAS, the Department of Health and Human Services has prepared the attached FY2009**
11 **Family Assistance 01-1300 Budget Amendment #2, which increases line item 866 –**
12 **Wake Assistance by \$293,150.00; adds new line items 862 – General Assistance at**
13 **\$61,000.00 and line item 864 – Child Assistance at \$1,500,000.00 for a total of**
14 **\$1,854,150.00 and has prepared the attached FY2009 tribal Family Assistance Budget**
15 **Amendment #2; and**

16 **WHEREAS, the projection for FY09 for wake assistance, general assistance and child assistance**
17 **services is based on actual projections for the period of April 01, 2009 through**
18 **September 30, 2009; and**

19 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**
20 **Assistance Division, FY09 Tribal budget amendment #2 to increase the Wake**
21 **Assistance line item by \$293,150; add new line items 862- General assistance at**
22 **\$61,000.00 and line item 864 Child Assistance at \$1,500,000.00 for a total of**
23 **\$1,854,150.00 which is attached and incorporated by this reference, to be effective**
24 **October 1, 2008 through September 30, 2009, and requests authorization to expend**
25 **funds. The fund source is the FY08 tribal surplus funds.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
27 **appropriate the amount of \$1,854,150.00 from the FY08 tribal surplus funds, and**
28 **approves and authorizes the Executive Branch to expend funds for the attached FY**



4 **of \$1,854,150.00.**


5 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairperson**
6 **and any designated official are hereby authorized to negotiate, execute and expend**
7 **funds, provided however, that any amendments affecting the funds or funding levels**
8 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
9 **Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25th . Day**
11 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
12 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI Section**
13 **1 (d)(2)& (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
14 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
15 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


