

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2009 Department of Health and Human Services Child Care and
Development Fund Supplemental Discretionary Funds Budget)**

RESOLUTION NO. 09-366

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child Care**
4 **Services to provide child care services to its young tribal members; and**

5 **WHEREAS, Public Law 111-5, the American Recovery and Reinvestment Act of 2009**
6 **(ARRA) appropriates additional Child Care & Development Fund (CCDF) Discretionary**
7 **funding for FY 2009 as part of the economic stimulus package; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**
9 **Budget as attached and incorporated by this reference, to be effective October 1, 2008**
10 **through September 30, 2009 and requests authorization to expend funds for the FY**
11 **2009 Child Care and Development Fund (CCDF) Supplemental Discretionary Funds in**
12 **the amount of \$461,148.00 in the following budget.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
14 **and approves the CCDF Supplemental Discretionary Funds Budget for period October**
15 **1, 2008 through September 30, 2009.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**
17 **Executive Branch to expend funds for the program listed herein above and as attached**
18 **in the amounts indicated, effective October 1, 2008 through September 30, 2009 for the**
19 **FY 2009 CCDF Supplemental Discretionary Funds Budget in the amount of \$461,148.00.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Official, to wit: the Chairman and any designated official are authorized to**
22 **negotiate and expend the budget, provided however, that any amendments affecting**
23 **the funds or funding levels of the budget shall be submitted for further prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25th. Day**
25 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI Section**
27 **1 (d)(2) and (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
29 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
