RESOLUTION NO. 09-368

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding provided by the Arizona**
3 **Department of Economic Security's (A.D.E.S.) Planned Social Services Block Grant**
4 **(S.S.B.G.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**
6 **members by providing for their welfare through various programs and services**
7 **designed to meet their special needs; and**

8 **WHEREAS, the Tohono O'odham Nation has negotiated an Intergovernmental Agreement, for a**
9 **five year term, with the Arizona Department of Economic Security for an Arizona**
10 **Department of Economic Security Planned Social Services Title XX Block Grant, in the**
11 **amount of \$120,644.00 per year; and**

12 **WHEREAS, the Arizona Department of Economic Security Planned Social Services Block Grant**
13 **Title XX FY09 Program Budget has been reviewed by the Human Resources**
14 **Development, Domestic Affairs, and Budget & Finance Committees.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves and authorizes the Division of Early Childhood Development Child Care**
17 **Services to incur expenditure from July 1, 2008 to June 30, 2009 under the FY 2009**
18 **A.D.E.S./S.S.B.G. Title XX Block Grant Program Budget in the amount of \$120,644.00 as**
19 **attached hereto.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
21 **the Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level shall be**
23 **submitted for further prior approval, and provided that the budgets for the fiscal**
24 **years 2010-2013 are subject to Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25th. Day**
26 **of JUNE, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI Section**
28 **1 (d)(2) & (3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
