

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Amendment #2 of the Elections FY-2009 Budget to add \$20,284.70**  
**for Payment of Per Diem and Mileage to the District Election Boards)**

RESOLUTION NO. 09-375

1 **WHEREAS, In accordance to the Uniform Election Ordinance, the Election Board has full power,**  
2 **jurisdiction and authority to conduct elections of public officers of the Tohono**  
3 **O'odham; and**

4 **WHEREAS, the current Election Board base budget amount of \$179,897.38 does not include funds**  
5 **to support the cost for payment of per diem and mileage to the District Election Boards**  
6 **to monitor the Nation's 2009 Special Initiative Election; and**

7 **WHEREAS, the Election Board request surplus funds to compensate the District Election Boards**  
8 **for their duties to monitor the Special Initiative Elections in their perspective district**  
9 **polling sites and the posting of election results; and**

10 **WHEREAS, the Election Board has devised a budget indicating in which line items additional**  
11 **monies will be needed for the FY-2009 Special Initiative Election.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **a one time appropriation in an amount of \$20,284.70 to the Membership Services**  
14 **Elections Office FY-2009 Budget, increasing the total amount to \$200,182.08 for FY-**  
15 **2009. Said amount of \$20,284.70 is to be appropriated from the Tohono O'odham**  
16 **Nation's surplus funds to pay the Tohono O'odham Nation District Election Boards for**  
17 **per diem and mileage, per the attached budget, retroactive to the orientation date**  
18 **that was scheduled on Thursday, July 02, 2009.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level shall be**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 6<sup>TH</sup>. Day**  
24 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,390.8 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and 204.7[02] ABSENT, pursuant to the powers vested in the Council by Section 1**  
26 **(d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
