

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving of Ali Chugk Community Carry Over Mining Royalty Budget FY' 2008
for FY' 2009)

RESOLUTION NO. 09-377

1 **WHEREAS, the Gu-Vo District Governing Council did meet on September 20, 2008 to approve Ali**
2 **Chugk Community Carry Over Mining Royalty Budget FY' 2008 to be carried into FY'**
3 **2009; and**

4 **WHEREAS, the Ali Chugk Community of Gu-Vo District is requesting to carry over Fiscal Year 2007-**
5 **2008 into Fiscal Year 2008-2009 in the amount of Thirty-Three Thousand Seven**
6 **Hundred Nineteen Dollars and Thirty-Nine Cents (\$33,719.39); and**

7 **WHEREAS, the Gu-Vo District Governing Council has determined that is in the best interest of the**
8 **Ali Chugk Community to request to the Tohono O'odham Legislative Council to grant**
9 **Ali Chugk Community to Carry Over FY'2008 Mining Royalty Budget into FY' 2009.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approve**
11 **the Ali Chugk Community FY'2008 Mining Royalty Budget Carry Over into FY' 2009 in**
12 **the amount of \$33,719.39.**

13 **BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its budget according**
14 **to the Tohono O'odham Nation's process, but any amendments affecting the funds or**
15 **funding levels shall be approved by the Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 6TH. Day**
17 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,390.8 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and 204.7[03] ABSENT, pursuant to the powers vested in the Council by Section 1**
19 **(d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
