

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance
- FY09 Food Distribution Program Budget Amendment #1 - Account No. 11-1315)

RESOLUTION NO. 09-384

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2009 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution Number 08-285, the Tohono O'odham Legislative Council approved the**
5 **FY2009 Food Distribution Program budget in the amount of \$192,444.28; and**

6 **WHEREAS, the Nation was notified of the final grant award for the FY09 USDA budget at**
7 **\$232,482.76; and**

8 **WHEREAS, the Food Distribution Program funds available to the Tohono O'odham Nation for**
9 **FY2009 through the USDA has increased by \$40,038.92 from \$192,444.28 to \$232,482.76;**
10 **and**

11 **WHEREAS, the Department of Health and Human Services has prepared the attached FY2009**
12 **USDA Food Distribution Program Budget Amendment #1 which increases the budget**
13 **by \$40,038.48; increases line items: 650 -Tuition at \$500.00; 660 - Travel Expense at**
14 **\$3,500.00; 720 - Supplies Office at \$3,365.00; 721- Supplies Other at \$15,000.00; 771 -**
15 **R/M Vehicles at \$720.00 and 772 - RM Building at \$2,000.00 and adds new line items:**
16 **710 - Utilities at \$4,629.00; and 770 - RM Equipment at \$2,000.00; and**

17 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY2009 Food**
18 **Distribution Program Budget Amendment #1 in the amount of \$232,482.76.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
20 **approve Amendment #1 which reflects the final grant award in the amount of**
21 **\$232,482.76 and authorizes the Executive Branch to expend funds in the attached**
22 **USDA Food Distribution Program Budget Amendment #1, effective October 01, 2008**
23 **through September 30, 2009.**

24 **Budget Amendment #1 increases the budget by \$40,038.48; increases line items: 650**
25 **-Tuition at \$500.00; 660 - Travel Expense at \$3,500.00; 720 - Supplies Office at \$3,365.00;**
26 **721- Supplies Other at \$15,000.00; 771 - R/M Vehicles at \$720.00 and 772 - RM Building**
27 **at \$2,000.00 and adds new line items: 710 - Utilities at \$4,629.00; and 770 - RM**
28 **Equipment at \$2,000.00.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
30 **Chairperson and any designated official to expend and administer the budget as**

attached, provided that any amendments affecting the funds or funding level shall be submitted for further prior approval by the Tohono O'odham Legislative Council.
