

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance – FY09**  
**Food Distribution Program Nutrition Education Budget Amendment #1 Account No. 11-1316)**

**RESOLUTION NO. 09-385**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**  
2 **Assistance Division, Food Distribution Program under an FY2009 grant with the United**  
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**  
5 **(commodity foods) and nutrition education to eligible households through tailgate**  
6 **distribution system throughout the Nation and nearby towns; and**

7 **WHEREAS, by Resolution Number 08-286 the Tohono O'odham Legislative Council approved the**  
8 **FY2009 Food Distribution Program, Nutrition Education budget in the amount or**  
9 **\$1,939.00; and**

10 **WHEREAS, the Tohono O'odham Nation was notified of the final grant award for the FY2009 USDA**  
11 **Food Distribution Program, Nutrition Education budget in the amount of \$2,148.30,**  
12 **which is an increase of \$209.30; and**

13 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
14 **Division, Food Distribution Program has prepared the attached FY2009 Nutrition**  
15 **Education budget amendment #1 which increases line items 721 Supplies Other and**  
16 **900 Indirect Cost; and**

17 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY2009 Food**  
18 **Distribution, Nutrition Education program budget amendment #1 in the amount of**  
19 **\$2,148.30.**

20 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
21 **authorizes the expenditure of the FY2009 Food Distribution Nutrition Education**  
22 **budget Amendment #1 which increases line items 721 Supplies Other and 900 Indirect**  
23 **Cost for a total budget of \$2,148.30 which is the final grant award amount for FY2009.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairperson and any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding level shall be**  
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7<sup>TH</sup>. Day**  
29 **of JULY, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
30 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)(3)**  
31 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
34 **Stat. 984).**
